## FEELING SAFE POSTER

We have produced a poster to explain that the church safeguarding coordinator can be contacted if there are concerns. This is to send out a clear message that the church supports safeguarding disclosures and will listen. This poster could be displayed on the back of toilet doors on notice boards.



This is not to place onus on the Safeguarding coordinator that they will directly support with all the issues but to promote that they are there and can be contacted for support. The Safeguarding coordinator can then liaise with the SSO about referrals or any additional support. ## INDEPENDENT INQUIRY INTO CHILD SEXUAL ABUSE (IICSA) - AN UPDATE

You may recall that the URC were core participants in one of the 15 investigations led by the inquiry the URC was part of was for Child Protection and Religious Settings. There were 2 final recommendations from that inquiry along with 85 recommendations from the other inquiry investigation. The final IICSA report was published in October 2022 and has 20 recommendations which were presented to the UK and Welsh government for a response within 6 months, in May the response was presented in Parliament and can be read [here](#)

The General Assembly Safeguarding Committee have supported a small working group to come together to produce a URC reflection report on the findings of IICSA and what this means for the URC, this report should be available in early 2024 with any recommendation or resolutions coming to summer General Assembly in 2024.

# STAFFING UPDATE

We welcome Ben Twelves as the new Synod Safeguarding officer for East Midlands Synod. He says 'Hi' right here!

My name is Ben Twelves and on 1 May 2023 I started my new role as Synod Safeguarding Officer for the East Midlands Synod. I want to say a big thank you to Carrie Kaunda and Donna Gordon who have looked after the East Midlands so well and are being incredibly supportive to me as I start my new role. It is really lovely to work with such great people at both the Synod office, and the central Safeguarding team and SSO teams.

I've been a primary school teacher for 17 years (including headship and deputy headship) and have worked as the Designated Safeguarding Lead in three different schools. I am also a member of the Fountain Square Church in Tideswell (in the Peak District) where I am the Church Safeguarding Officer.

As a URC/Methodist LEP we follow the Methodist Safeguarding policy, so I have a good understanding of the many complications and blessings of LEPs. As my synod role is part time, I am also continuing to do a small amount of supply teaching in my local village school so that I don't lose my teacher voice!

Our job on this earth is to show God's love to all people. It's a pretty big responsibility that we can't do on our own, but with his help, we will do it. Safeguarding has a big part to play in this mission. It must not get in the way of the job, but it is our way of making sure that our activities do not cause harm to people. If we allow any sort of abuse to exist in our churches without being addressed and dealt with appropriately, we present a horrific and incorrect image of God to the world and we fail to carry out our main mission.

Safeguarding is sometimes challenging and often frustrating but it should always be involved in all decisions that we make as churches and I am looking forward to supporting the churches in the East Midlands Synod in every way I can.
